Minute of meeting held at RBL, Rodney Street, Edinburgh at 1300 on 19 September 2010

1. MEMBERS PRESENT

Jimmy Simpson, Kim Panton, John Donaldson, Brian Earl, Andy Mullen, Frank Murray (Chairman) and Mick Walker.

2. CHAIRMAN'S REMARKS

Frank expressed his pleasure at Kim's attendance at the meeting and welcomed all. He went on to say that he had heard from the Lonergan family that they had received the Elizabeth Cross in recognition of John Lonergan's death in Aden in 1965.

The Chairman gave some detail of the Commemoration to mark the 35th anniversary of the tragedy at Cromwell Lock. Olaf Dudley has concerns about publicising this for security reasons but if anyone wants to attend this will happen on the afternoon of 26 September and they should contact him for details.

4. MINUTE OF PREVIOUS MEETING

The minute of the meeting of 18 July was agreed as a true record on the motion of Kim Panton who was seconded by Jimmy Simpson..

5. MATTERS ARISING

Kim asked that his family's thanks be recorded for the messages, cards, visits and general support they had received from members during his recent stay in hospital. He was particularly appreciative of Maj Robin Ward sending a message despite being subject to the medic's attention himself.

6. WEBSITE UPDATE

John said he intended to review the website in the near future. He added that the Airborne Engineers Association had closed the guest book on their website but had opened a forum.

7. TREASURER'S REPORT

Mick then put on his Treasurer's hat and reported that there had been little financial activity since the last meeting and we remained in a relatively healthy position.

Colin Reid's sad passing had left us without an Auditor and the meeting gratefully accepted Jimmy Simpson's offer to fill this role for the current year.

Mick reported that the staff at the RBL had been advised that the future of Rodney Street would not be determined until January at the earliest so we would be all right for an AGM venue.

12. DATE OF NEXT MEETING
